Subject: **GENERAL ORDER: Support for Farmworkers Union.**

### **Background**

The United Farm Workers Union, (UFW) is attempting to unionize huge factory farms in eastern Washington whose products are sold to our members in Western Washington. Teamsters, Local 117 are supporting the United Farm workers organizing effort. The United Farm Workers, (UFW) was successful in organizing two dairies in Oregon that supply Tillamook Cheese. Tillamook did the right thing and pressured the dairies to allow unionization. See attached website for a model for better dairies; <http://www.threemilecanyonfarms.com/>

While Darigold advertises and promotes a small farm image, many of the farms are huge industrial farms residing in eastern Washington: Ruby Ridge dairy in Pasco, DeRuyter Brothers in Sunnyside, and 5-D Dairy in Pasco. The 5-D dairy milks 40,000 cows 3 times daily and there are 400 farm workers employed. At Ruby Ridge Dairy they milk 10-15,000 cows with 50 to 100 workers in 3 eight hour shifts.

- Workers are not given breaks or time to have a lunch break.
- Workers are expected to work off the clock to milk all the cows in an 8 hour shift.
- Workers have been fired for injuries.
- Large Companies like Walmart and Costco sell Darigold products.
