<u>Treasurer's Report</u>: Shaunna said TJ is working the SPEEA budget and she has also been working for 2022 dues and they will be \$51.86.

<u>President's Report</u>: Ryan said Boeing has withheld too much for Washington Paid Family and Medical Leave (far too much for MLI and not enough for FLI). Matt requested he send him his information since it most likely happened to more than just him. Ryan also noted that a member reached out to him about wanting Juneteenth as a Boeing holiday. Matt said he has that on his negotiations list. RMatthew noted that Spirit gets a "diversity day" every year.

**Executive Director's Report**: Ray said two of our staff members got Covid over the break, both are fine now. With the vaccine mandate the Supreme Court should give clarity but it can take a while.

Ray reported with the grants we received we will be able to hire a new employee to work all the grant things, but the state will only reimburse so we will need seed money to start the process. He will come to the board with a proposal. Ray said we are also working with our lawyers to create a 501C3 to run the grant through.
