Background

SPEEA was supported by UFCW (United Food and Commercial Workers) & Teamsters during our strike in 2000.

These grocery store workers are facing a horrible first offer from their employers. Unions need to support their efforts to help them in their fight for a good contract. UFCW local 367 is negotiating for Pierce county workers.

UFCW 21 & Teamster local 38 cover King and other counties. They are starting to have informational picketing. The next bargaining session on Health Care is June 7th.

SPEEA member's ways to support these workers can be by joining them in their efforts, and letting the workers in the union grocery store where they shop know SPEEA supports them in getting a fair contract. The proposal from the employers start with cuts such as pay cuts back to minimum wage, no shift differential pay for nights and weekends, cutting holiday pay including Christmas and New Year's eve. It is further moved that the Northwest Council requests the SPEEA Executive Board grant up to \$3000.00 to the locals involved should a strike happen at the grocery stores.

THE UNION BARGAINING TEAM REJECTED ALL OF THESE PROPOSED CUTS.

UNION PROPOSED:

- Journey Wage Increases:
- 30 year: extra \$1.50
 - Cumulative

- Year 1: \$1.50
- Year 2: \$1.50
- Year 3: \$1.50
- Plus longevity steps at 15, 20 and 30 years.
- 15 year = extra 50 cents
- 20 year = extra \$1.00Cumulative

- All Classification in Grocery (Bakery, Deli, Fuel, Clicklist, General Merchandise, etc.) all move to "Appendix A" (the highest current scale
- All Service Counter in the meat department moves to Wrapper Scale.
- Increase escalators from 10 cents to 40 cents

- between each step so we have a real wage scale.
- Premium pay for Department Leads, Section Heads, and Designated Trainers of no less than \$1.00.
- **Meat Cutters** Apprenticeship bonus of \$1,500
