The Northwest Legislative and Public Affairs (L&PA) Committee hosted a panel of labor candidates Oct. 26 to discuss the importance of local elections and their impact on working families.

The panel included SPEEA members running for local public office.

Hanan Amer, SPEEA member, running for Auburn City Council (www.voteamer.com)

Amer was born in Oklahoma, grew up in Bengazi, Libya, and moved to Auburn in 2008. She's active in her community as a

volunteer starting with the food bank and local museum and continuing with the Girl Scouts, United Way and Auburn police. "My passion is serving my community through volunteering."

When the COVID-19 pandemic hit, she curtailed her volunteering but wanted to stay involved. The tipping point to run for Auburn City Council came when she heard Council members opposing hazard pay for workers during the pandemic.

Amer, a SPEEA-Boeing engineer, credits

other union leaders and activists with helping her run for office, including Washington State Labor Council (WSLC), AFL-CIO, President **Larry Brown**, who is an Auburn City Council member, and Everett Council Rep **Benjamin Briles** who is a Mill Creek City Council member.

Briles was appointed to serve on the City Council last year and is running to serve another term. He shared his goals to

help Mill Creek become more welcoming, especially for varied income levels.

He cited examples of divisiveness and rhetoric, particularly over the addition of subsidized housing. The subsidy, for those earning 60% or less of the median wage, could apply to people who work at Boeing such as early career engineers, techs or machinists, he said.

Prior to the Council seat, Briles, a Boeing engineer, served on the Mill Creek Arts & Beautification Board and Snohomish

The SPEEA Executive Board issued guidance to assist represented employees who are seeking an exemption from their employer's vaccine mandate requirements.

The guidance, which is online at **www. speea.org**, addresses both medical and religious exemption requests.

# Weingarten Rights reminder

Union-represented employees have the right to have a Council Representative or other union official present during meetings that may lead to discipline. SPEEA Council Representatives are trained to assist employees during these meetings.

This includes meetings about compliance with vaccine mandates, requests for exemptions and other investigatory issues.

Members should seek assistance before discussing issues with management or Human Resources (HR).

# SPEEA helps sponsor events honoring civil rights leader

PEEA is one of the sponsors of community events Nov. 6-8 to honor the legacy of civil rights activist Martin Luther King Jr., Ph.D.

Dr. King's son, Martin Luther King III, is a special guest for the events coinciding with the  $60^{\rm th}$  anniversary of Dr. King's visit to Seattle.

The events include an opening ceremony, town hall forum, a bus and bike tour visiting the sites where Dr. King visited, an interfaith youth program and an award ceremony, featuring King III, Nov. 8.

The commemoration is hosted by the Northwest African American Museum (NAAM), Seattle, and organized by a 40-person community wide planning committee.

King III is the oldest son of Dr. King and Coretta Scott King. Following in his father's footsteps, he is a human rights advocate and community activist. King III served as the fourth president of the Southern Christian Leadership Conference from 1997-2003. He's led marches, convened police-brutality hearings and organized programs.

#### **About Dr. King's 1961 visit**

Dr. King received an invitation to come to Seattle in November 1961 from Rev. **Samuel B. McKinney**, pastor of Mt. Zion Baptist Church. The two were classmates at Morehouse College.

At the time, Seattle was considered one of the most segregated cities in the North.

Starting in 1974, local leaders renamed a school, a park, a roadway and the county in honor of Dr. King.

County Planning Commission. His experiences as a Council Rep and member of the SPEEA NW L&PA committees help him "understand how to build networks and hear how people want you to vote."

Toshiko Hasegawa, labor activist and Port of Seattle candidate (www. hasegawaforport.com)

Hasegawa comes from a family of union leaders. Her father, a truck driver, served for many years as secretary treasurer of Teamsters Local 174. Both of her parents, who

are still union members, taught her to fight for her beliefs and believe in the power of solidarity with others to reach goals.

Hasegawa is the executive director of the Commission on Asian Pacific American Affairs (CAPAA), a Washington state agency.

She sees the Port as an economic driver of good-paying jobs, but she also has concerns about air and water pollution, the lack of transparency at the Port and the power of "big money" fueling other candidates' races.

"What the Port does next will affect the trajectory of our future," she said.
