ongratulations to members of the Seattle Times Union. They have a new contract securing a 9.24% raise over the three-year contract, with more for the lowest-paid members.

Highlights of the contract gains include a ratification bonus, improved parental and bereavement leave, seniority for grant-funded employees and quicker access to health insurance for new employees.

The union thanked the more than 1,400 petition signers who supported their fight and urged the Seattle Times executives to

respect their workers.

Since 1936, Seattle Times employees have been unionized. Seattle Times Union is part of the Pacific Northwest Newspaper Guild (TNG) Communications Workers of America (CWA) Local 37082. Currently, Seattle Times Union represents 170 workers from the newsroom, advertising, marketing, circulation and operation departments. In 2020, digital employees in the newsroom joined the union.

## **IFPTE supports Maui fire relief**

FPTE Local 121, Aiea, Hawaii, made a donation to help their sisters and brothers affected by the devastating Maui wild-fires.

The IFPTE Executive Council made a matching donation to Local 121's \$9,000 total donation (\$4,500 each) to Hawaiian Red Cross and Salvation Army.

IFPTE Local 121 President Jamie Uyeunten, western federal area vice president on the IFPTE Executive Council, wrote in a letter to IFPTE:

"While IFPTE Local 121 does not have bargaining units in Maui, many of us have family and friends on Maui or know of family or friends that

have loved ones on Maui. In this respect, Hawaii is a small place, separated from anywhere near by the vast Pacific Ocean; however, we are strong in our bonds of aloha and ohana, family."

The letter continues: "IFPTE Local 121 sends our condolences to all of those impacted by the devastating wildfires on Hawaii's island of Maui. Our hearts and prayers go out to all who are affected. IFPTE Local 121 is here to help in every way that we can, in solidarity for our Maui community and Hawaii."

Local 121 represents members who work for the Department of the Navy at Pearl Harbor Shipyard.
